this document outlines
Tuition and Fees
for the 2012-2013
Academic Year.

- **Boston** students enrolled in 12 to 18 credits for fall and spring semesters will be charged the flat tuition rate for qualifying programs.
- **Boston** students enrolled for less than 12 credits for fall and spring semesters, including graduate students, will be charged \$980 per credit.
- All students enrolled for more than 18 credits for fall and spring semesters will be charged \$980 per credit in addition to the flat tuition charge.
- **Boston PharmD** registrations in excess of the cumulative 69 credit threshold will be charged the professional rate.
- **Boston** students enrolled in summer sessions are charged at a per credit rate, *except for students enrolled in Nursing, Medical Imaging and Therapeutics, or Dental Hygiene*. Students enrolled in 9 or more credits in the summer will be charged the flat tuition rate.

- **Manchester and Worcester** students enrolled in 6 or more credits per semester will be charged the flat tuition rate except for Nursing students.
- **Manchester / Worcester Nursing** students enrolled in 12 to 18 credits will be charged the flat tuition rate for fall and spring semesters. Students enrolled in 9 or more credits in the summer will be charged the flat tuition rate.
- **MCPHS Online** Graduate students will be charged \$850 per credit.
- **MCPHS Online** Undergraduate students will be charged \$650 per credit.

Other program/campus specific tuition policies are noted below.
(The College reserves the right to adjust these fees in accordance with possible rate changes.)

College Withdrawals, Drop/Add Period and Refunds

Withdrawals

The following graduated scale of charges for tuition and residence hall fees is used for purposes of determining refunds for students withdrawing entirely from the College during the semester.

| PERIOD OF ATTENDANCE | Refund |

| First week after the Drop/Add period | 50% |
| Second week after the Drop/Add period | 25% |
| Third week and beyond after the Drop/Add period | 0% |

Students who withdraw from the College must contact Academic Support Services at the time of withdrawal and complete an official form. Approved refunds are computed on the basis of the date appearing on the form. Absence from class without completing the form does not constitute withdrawal from the College.

Drop/Add Period

During the Drop/Add period, courses are fully refundable for a course withdrawal. Tuition accounts are adjusted automatically, and any additional charges must be paid at the time of the transaction. After the Drop/Add deadline, there will be no tuition refund for individual course withdrawal.

Refunds

Student refunds are available 1–2 weeks after the Drop/Add period. Student refunds will be issued via direct deposit into a student's checking or savings account. Students should enroll through WebAdvisor. For questions about direct deposit, enrollment or terms and conditions, please contact Student Financial Services.

Health Insurance Policy

According to the Commonwealth of Massachusetts and MCPHS policy, all Boston, Worcester and Manchester matriculated students (regardless of enrollment) must be covered by a comprehensive health insurance program. The College makes available a general health insurance program that meets these standards. This policy is provided by an independent carrier beginning September 1 and continuing 12 months. Students will be automatically enrolled in this plan unless an electronic waiver is processed and received by Student Financial Services prior to August 1. Instructions for electronically completing the waiver will be sent with the fall semester billing and will also be posted on our website at www.mcphs.edu. Students registering late must complete the electronic waiver at the time of registration. The waiver stipulates that personal coverage will be maintained during the enrollment period. If Student Financial Services does not receive the electronic waiver prior to August 1, the student will be billed for the insurance premium and will remain responsible for said premium. The waiver must be processed annually.
