The primary issue with poor writing in business is the loss of trust. This loss of trust leads to a multitude of other problems. In the business world, the end state is to make a profit in order to make a livening. This loss of trust affects that. The problems can become even greater in companies that deal with international business. Although academic and business writing differ, they do have some similarities. One of those similarities which applies to just about all types of writing is purpose. Both styles of writing must have a purpose foe being written. Along with this purpose, there

needs to be clarity which is the second similarity. If the purpose of either style of writing is not clear and concise, it will be ineffective and a waste of time. The third similarity is the general rules of vocabulary and grammar. Both academic and business writing follow the same rules of the basic grammar and vocabulary words set by that language.

3. What are the differences between academic writing and business writing? Try to come up with at least three of them. Please write a paragraph or two in posting your answer.

There are many differences between academic and business writing. One of those is structure. In academic writing, you have the basic structure of an essay which consists of an introduction with thesis, body, and conclusion. Business writing in each of its own genres (email, memo, resume, etc.) has its own structure that does not always follow academic format. In academic writing, the context of an argumentative essay differs from context of business writing that may need to convince someone. Examples of that are an email to persuade a business partner to change their safety procedures or a resume trying to persuade a potential employer to give you a job interview. The third difference is readership. In academic writing, usually you have one audience which is your normally a professor or someone who is grading your writing. In business writing, your audience may be multiple audiences such as in a report addressing safety issues to multiple department heads in a company
