

The Assignment

Imagine that you are a hospital administrator exploring the possibility of instituting a program similar to Dr. Brenner's. Create a presentation (Powerpoint, Prezi, Voicethread, etc) designed for an audience of other hospital administrators and executives that:

- Support your evaluation with citations from the Learning Resources or other relevant research that you conducted on your own.
- Includes any crucial content that you would present (but that does not appear in the presentation) in the Notes area for the slides.
- Please include an introduction and a conclusion as you would in any presentation
